

# FORMER PLASTIGAGE SITE 2917 Wildwood Ave, Jackson, MI

## SITE BASICS

**Size:** 14.16 acres, 157,800 sq ft vacant building  
**Asking Price:** Price is negotiable  
**Ownership Status:** Even Stevens Investments, LLC  
**Zoning:** Industrial and Commercial available  
**Regulatory Status:** Unknown  
**Characterization Status:** Assessments complete and Brownfield Plan for TIF underway  
**Estimated cleanup costs:** Unknown at this time  
**Utilities:** Municipal water and sewer, natural gas and electric  
**Current/Former Use:** Currently vacant, but since about 1930, the property appears to have an industrial use.  
**Property Liens:** None  
**Absorption Rates:** No known restrictions or easements  
**Site Access:** I-94 is approximately 1 mile North of the site, with US-127 roughly 2 miles from the site. Corporate airport in Jackson, plus Lansing and Detroit airports are within an hour.  
**Surrounding land uses:** The property is located within an area of several commercial properties. A baseball field lies to the west and a railroad track lies to the south. A small manufacturing building is located to the northwest.  
**Adjacent Properties:** Adjoining 3-acre parcel may be available  
**Property Tax Rate:** 45.22 mills *(The state and local tax burden is 13th lowest in the United States.)*

## SITE OVERVIEW

The site is a former industrial property consisting of 3 parcels of land, occupying roughly 14.16 acres and a vacant building equipped with sprinklers, 5 loading docks and substantial power available. Owner will consider demolition to clear site for new construction. The site is located within an area of commercial development within Blackman Township.

## INCENTIVES

**P.A. 198** - Allows a local tax savings of 50% in real and personal property tax, up to a maximum of 12 years, for an eligible Industrial facility.

**Revolving Loan Funds and Industrial Development Revenue Bonds** are available through the County's Economic Development Corporation.

**Michigan Business Tax Credits (MBT)** - The site is a brownfield and an eligible company could qualify for MBT Credits through the Brownfield Redevelopment Authority of Jackson County.

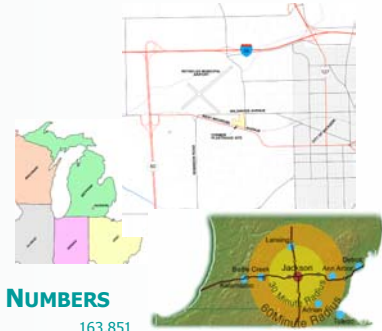
